



Photo Release Form

I hereby grant Lamar Advertising Company (hereinafter "Lamar") the right use the _____ photograph, a copy of which is attached hereto as Schedule A (hereinafter "Photograph") without payment or any other consideration as set forth herein. However, I acknowledge that Lamar and I shall have the right to terminate Lamar's use of the Photograph upon written notice at any time and for any reason. Should I provide written notice to Lamar of my intent to terminate its use, Lamar agrees to discontinue all future use of the Photograph within 60 days of Lamar's receipt of written notice, but only if I am current in all payments to Lamar. I acknowledge and agree that Lamar shall remain free to obtain license rights in the Photograph from third parties.

_____ I agree to release all rights in the Photograph to Lamar for use in any advertising materials designed by Lamar, which may be subsequently released for use in other media and materials. In consideration thereof, Lamar will use reasonable efforts to ensure that the Photograph and any adaptation thereof, will not be used for any pornographic, obscene, defamatory or libelous purpose. I further hereby irrevocably authorize Lamar to edit, alter, copy, display, publish, distribute, or otherwise disseminate the Photograph and any adaptation thereof for advertising purposes. In addition, I hereby waive the right to inspect and/or approve the finished product, including written or electronic copy, wherein the Photograph or any adaptation thereof unless specifically requested in writing. Additionally, I waive the right to any royalties or other compensation arising or related to the Lamar's use of the Photograph.
